

# **Reasonable Adjustment and Special Consideration Procedure**

#### 1. Introduction:

#### 1.1 Purpose:

The purpose of this Reasonable Adjustment and Special Consideration Procedure is to ensure that all students at XYZ College have equal access to educational opportunities and assessments. ## 4. Types of Reasonable Adjustments:
